

### **CUT-THROUGH CLAUSE (A)**

It is agreed that in the event of the failure of the Insurer(s) to pay a recoverable claim under their policy for account of original Assured, original Assured shall be entitled to recover claims directly from reinsurers and/or through their Broker only for the proportion subscribed by reinsurers subject to all premium due as of the date of loss be settled.
